SUMMARY

Offer Price and net proceeds from the Global Offering

- The Offer Price has been determined at HK\$1.46 per Offer Share (exclusive of brokerage fee of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$1.46 per Offer Share, the net proceeds from the Global Offering to be received by the Company, and after deducting the underwriting commissions and other estimated expenses payable by the Company in relation to the Global Offering, is estimated to be approximately HK\$59.2 million. The Company intends to apply such net proceeds in the manner set out in the paragraph headed “Net Proceeds from the Global Offering” below.

Applications under the Hong Kong Public Offering

- A total of 15,802 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms, electronic applications under the HK eIPO White Form service and through giving **electronic application instructions** to HKSCC via CCASS for a total of 7,066,674,000 Hong Kong Offer Shares, equivalent to approximately 1,177.8 times of the total number of 6,000,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering. The final number of Offer Shares under the Hong Kong Public Offering is 30,000,000 Offer Shares, representing 50.0% of the total number of Offer Shares initially available under the Global Offering.
- Due to very significant over-subscription in the Hong Kong Public Offering, the reallocation procedures as described in the section headed “Structure and conditions of the Global Offering — The Hong Kong Public Offering — Adjustment” in the Prospectus have been applied. As the number of Offer Shares validly applied for in the Hong Kong Public Offering represents 100 times or more of the number of Offer Shares initially available under the Hong Kong Public Offering, 24,000,000 Shares have been reallocated to the Hong Kong Public Offering from the International Placing, so that the total number of Offer Shares allocated to the Hong Kong Public Offering has been increased to 30,000,000 Offer Shares, representing 50.0% of the total number of Offer Shares initially available under the Global Offering.

The International Placing

- The Offer Shares initially offered under the International Placing have been moderately over-subscribed. The final number of Offer Shares allocated to 289 placees under the International Placing is 30,000,000 Offer Shares after reallocation to the Hong Kong Public Offering, representing 50.0% of the total number of Offer Shares under the Global Offering. A total of 242 placees have each been allotted no more than four board lots Shares or less, representing approximately 83.7% of the 289 placees under the International Placing after reallocation of the Offer Shares from the International Placing to the Hong Kong Public Offering. These placees have been allotted approximately 4.0% of the Offer Shares under the International Placing after reallocation of the Offer Shares from the International Placing to the Hong Kong Public Offering.

No Offer Shares placed by or through the Joint Global Coordinators and the Underwriters under the Global Offering have been placed with any core connected person (as defined in the Listing Rules) of the Company or any “connected clients” of the lead broker or of any distributors (as set out in paragraph 5(1) of the Placing Guidelines) or persons set out in paragraph 5(2) of the Placing Guidelines or any existing public holders of Shares or their close associates, whether in their own names or through nominees. The Directors confirm that none of the Sole Sponsor, the Joint Global Coordinators, the Joint Bookrunners, the Joint Lead Managers and the Underwriters and their respective affiliated companies and connected clients (as defined in Appendix 6 to the Listing Rules) have taken up any Shares for its own benefit under the Global Offering. No placee will, individually, be placed more than 10% of the enlarged issued share capital of the Company immediately after the Global Offering and as such, none of the placees under the International Placing will become a substantial shareholder (as defined in the Listing Rules) of the Company after the Global Offering and the public float of the Company will satisfy the minimum percentage prescribed under Rule 8.08(1) of the Listing Rules.
